 Saba Farbodkia (President) - Apologies for not sending in a written report. I'll go over what I have been doing for the last few months.

November: Senate meeting on racism and diversity; governance committee meeting was formed. Those people elected to position, in case you are interested in

Meeting with Finance meeting – regarding the structure of the SGPS; doing a review of the SGPS in regards to staff. Talked about some difficulties in doing some of her own research

Meeting with Principal: International innovation – increasing enrollment of students coming from the United States. Just following up with the promise to take to (ask about committee name re: quality insurance) for curriculums for University.

Had a meeting with Student Afairs – currently working with policy changes.

Also working on a graduate student enrollment task force. Many Canadian universities have issues with decreasing domestic doctoral applications; need to create incentives. Have begun this discussion to push for incentives for Queen's

SCAD meeting – discussion about two programs (developing) in education and business. Education would be a joint program with one in China (cultural exchange opportunities). Be able to talk about professional programs and adjust specialty programs to reflect cultural diversity.

During November, had a meeting with the local Federal MP and the Prime Ministers Secretary of Finance – large people coming from Queen's re: innovation and economic inequality to incorporate into budget.

Did a follow-up with a local MPP (Garretsen) – immigration issues in Kingston – more innovation in Canada. For-profit vs. not for-profit...

Workplace harassment policy committee – some concerns re: reporting mechanisms; would go against confidentiality.

Board of Trustees meeting – read an open letter by a member about issues of racism and the way it is discussed on campus. Student asked her for help – used opportunity to voice concerns.

Update on Equity Standing committee – started the working group.

 Sebastian Gorlewski (VP Graduate) - Dedicating this mo

Sebastian Gorlewski (VP Graduate) - Dedicating this month to mental health audit of SGPS members – reiterate objectives: 1) to understand SGPS members knowledge of existing resources; and 2) what is the perception of these resources and how we can improve access and quality to students. Will discuss later in the agenda. Let him know of any feedback. With suggestions, we're hoping to make some changes with the upcoming referendum in lobbying.

SGS needs a student to sit on an academic appeals Board – academic appeals Board occurs when a student is appealing an academic decision (ex. Plagiarism, comps...etc.); in order to ensure non-partisan response, need a graduate student to sit on a representative; ensure that graduate student interests are being met. As the student is a humanities student (History), we have to recruit a humanities student not in History. Please let me know.

# BIRT Policy P.1.2.4.f.b.i.3 Establishing, Increasing and Renewing Student Activity Fees is amended to read:

A petition that specifies the Fee to be established and bears the signatures of at least 100 ordinary Society members, in accordance with the guidelines set forth in B.10 and P.9, delivered to the CRO;

From what is currently written:

A petition that specifies the Fee to be established and bears the signatures of at least 7.5% of ordinary Society members, in accordance with the guidelines set forth in B.10 and P.9, delivered to the CRO;

#### BIFRT this policy takes effect immediately and is not grandfathered in.

Stuart Clark (VP Finance & Services): Minor housekeeping issue. Allowing a referendum for student fee to be on the ballot. Could bring forward a petition of 10% of the SGPS membership or come to Council to be voted on. When we changed eligibility requirements, we set a standard of 7.5%, but in recognition of the ½ to get on the ballot, we're going to reduce that amount by about 1/3 the numbers change to now. Large groups and small groups alike are both able to get onto the ballot. You see it twice because the policies and bylaws outline these numbers twice. 7.5% as a general membership is about 300 people. This represents a 2/3 reduction

Adam Ali (Graduate Student Senator): Question about the wording. For both of these is the establishment and increasing a student fee?

Stuart Clark (VP Finance & Services): They have roughly the same package requirements. But it's written twice in policy, hence the change twice.

Joanna Rees (Urban and Regional Planning Department Representative): Just to clarify, we are planning to go from 300 to 100 people?

Sebastian Gorlewski (VP Graduate): Described objectives. Sending out on January 31<sup>st</sup> or February 1<sup>st</sup>. Looking at incentives to get a 10% response rate of it. Robert Sutherland Room, John Deutsch University Centre Adam Ali (Graduate Student Senator): This is a survey focused on resources specific; why is that?

Sebastian Gorlewski (VP Graduate): Reason to not go towards evaluating students' mental health – University participates in the NCHA – done across various Universities. Jenny was one of the researchers in 2013. Looking not to evaluate mental health (don't have the resources); looking to see if students are aware in resources and changes in accessibility (e.x. SWS hours), issues with accessing counsellor...etc.

Adam Ali (Graduate Student Senator): This survey is not asking very many questions; are there questions that ask about major factors that contribute to mental health and wellness. Use those factors to assess resources.

Sebastian Gorlewski (VP Graduate): One concern is that we want a high response rate. Have kept it concise – 3 pages. Good way of getting 2 questions answered while asking one.

Emma Thompson (Kinesiology Department Representative – Arts): Specifically with Q13 – should you have an additional column about not knowing if the resource existed. Add an extra column.

Sebastian Gorlewski (VP Graduate): Thought process would that students would select NA if they were unaware. Should add more to that.

Lauren Brick (Graduate Education Representative – MEd): Question 12: N/A – didn't know such services. Should be an option about not knowing about the resources/haven't used them. Forced to answer vs. voluntary? If they didn't want to answer a question is it mandatory? If they skip a page how are researchers interpreting the response?

Sebastian Gorlewski (VP Graduate): Not quite such I understand what you're asking.

Lauren Brick (Graduate Education Representative – MEd): Q12, you have a number of options; if I'm going to answer those, can I just go to the next page? How is a researcher going to interpret this?

Sebastian Gorlewski (VP Graduate): Yep. I should add a more nuanced way to respond to that.

Sebastian Gorlewski (VP Graduate): You don't think Q15 addresses that though?

Lauren Brick (Graduate Education Representative – MEd): Yes and no. Because you're saying that they kind of assume of the resources. It's kind of limiting in my opinion.

Adam Ali (Graduate Student Senator): Question kind of assumes that there are other resources available. Need to add What resources that are not offered at the Universitiy...

Michael Luoma (Philosophy Department Representative): Reading Week doesn't really apply to Graduate Students. Because that might not be totally understood by the graduate population. Question 16 might be a little ambiguous. IT just might be good to note that an Undergraduate Reading Week.
