b. VP Graduate – Courtney Bannerman (report attached)

Courtney

Hello, can everyone hear? Okay. I don't have much to add, would like to draw attention: Reduction in international tuition for PhD students went through. Next, all entering SGS next Fall will be assessed the new tuition. Current students will need to make the switch, though. All international PhD students should have gotten an email asking them to log in to Solus, so they need to identify that they want reduced tuition. This is because the University cannot just change tuition since they were offered with a certain funding and tuition amount. Deadline to do that is May 1st; if they do not do that by this date, they will have the higher tuition and will not be able to make this change with any exceptions.

Also doctoral defense procedure will be very similar. A lot of what the committee did was answer questions and make things easier to schedule; only thing impacting summer graduation is four different levels: Pass, pass with major revisions, referred, fail. Pass with revisions is that the student would need to rewrite some of the thesis but don't need to change it or defend again.

Last thing: Extension of stipend for those affected; SGS has committed to extension if they were supposed to graduate in 2020-21 year, but question is if earlier career students had their work impacted and should need to have an extension. There should be more light shed on this on how they want stipends to be handled, but we are advocating for all to take a 5th year if they need it. That's all, but I'm happy to take any questions.

Q (Chloe Robinson): Question about bio grad council, they have discussed request to continue funding for all grad students and were writing a letter to Dr. Kadir and were wondering if SGPS was also releasing some statement that we could jump behind or if other departments were also writing letters.

A: You can either find others that are writing letters in other departments, but for this to pass we need a certain amount of pressure, so if you can add a bit of pressure to that then it would be good.

Anthony Lomax: Point of joint statement is to allow folks to get signatures from faculty members as well as other students, in order to make a stronger case to the administration, hoping unit heads and faculty will sign on. I signed a joint statement, a few other folks have contributed, and sent to PSAC. Justine and I are meeting tomorrow to send this out to council reps and PSAC will be doing work in departments as well.

Q (Norris Roozmon): Also bio grad student with Chloe. Similar question because in meeting yesterday, stipend for students doing 7th semester wouldn't apply if graduating in spring of 2021, only fall of 2021. But what I just heard from Courtney is that it would extend across the board, hearing different statements.

A: Stipend amount won't be increased, but campaign is for increasing stipend for PhD students to a 5th year. Of course, waiting for official word. Of course, Master's students are affected too because they may have spent the majority of their time in grad school without ever going on campus. It's challenging to plan the campaign because we're waiting on word from SGS to target what we're asking for. If that protocol isn't out this week, we're going to continue anyways.

Norris: I wasn't asking about stipend increase. Rather, if Master's student needs a 7th semester, graduating in spring or fall of 2021 won't be given that stipend. Not expecting increase, but if someone taking that semester would be given a stipend still.

Courtney: Agreed that they want to drop that stipend extension, but we will be pushing for stipend extensions for Master's and PhD students.

There will be time for questions, hoping to get discussion with upper levels of University with that discussion. Conference is called Scholarship Beyond Boundaries, lots of great panels so look on the website for more about that. Something else I have been working on and can't quite remember, but those are good starts for right now.
